## **Minutes**

- 1. Treasurer's Report was presented by Mark Bailey. Discussion was held. Betty Lou Jones made the motion to approve and Sonja Cappelleri seconded. The motion passed unanimously.

- 4. President's Report presented by David Griffith
  - Retirement Update
  - Insurance Changes: an explanation of the change was presented through an illustration from Dave. Office co-pays have gone from \$15 to \$20. The paperwork from the District will be changed to reflect the actual agreement.
  - Insurance Committee Help is needed for the committee. The
    committee looks at the plan and recommends changes to the
    negotiating team based on industry change. The secondary function is
    to provide the final arbitration of a denial of payment. Interested

  - IEA RA and the budget: Dave McMurtrie reported reasons behind the possible dues increase.
  - Interest-Free loans for Tuition: The application form has been provided employees and the District has been receiving these.
