5. Presidents Report

Mark

- Redistricting Mark attending the last board meeting. Working on redistricting again tonight. Mill,
 Beebe, and Steeple Run seem to have most issues with crowding is supposed to present a
 modified version 6. Elmwood would receive majority of overflow from Mill. Beebe is being shipped
 to Steeple. Steeple is being shipped to Ranch View. This has put K preview on hold.
- All Day Kindergarten had enough votes to pass but didn't go for vote. Superintendent related reason to put on hold was due to pension. Put on hold till September. \$2 million to run all day K, \$7 million to make building modifications.
- Professional growth committee met again last Monday. Focus group is going to be pulled together
 to review the plan/idea. There will be report to the board in May. Depending on what the board says,
 will determine next steps.
- SB 7 Team meeting the NUEA group has met. Assignments have been made to various groups to come up with the best ways to evaluate under our new evaluation system that begins 9/1. If administration are not certified by 9/1 they can't evaluate. Teachers will have more input in the evaluation of principals/assistant principals under the umbrella of climate. Need to be honest on the forms and put down what is going on. Put down what is fair in terms of what is within the principals/ap's role. Teachers need to be professional on the survey and get everyone to do it.
- Negotiations team meeting update team has meant and have reviewed the information back from
 October along with information from Mark. The information will go up on the NUEA website.
 Nothing has been negotiated at this point in time or pre-negotiated. Questions, additions need to go
 to Carol Higgins. Negotiations will start in the first week of Feb 2013 per the contract.
- IEA Convention Mark shared IEA video that was showcased at the convention. There was a \$10 media increase to dues to address some of the media needs. Also shared the video from WI. Links to videos will be placed on the website. Mark will forward the links to the videos tomorrow. Need to tell legislatures that it is their obligation to pay our pension. Lobby days are coming up. Over a billion dollars a year lost in income between loop holes. Dave spoke regarding issues 90% of the tax cuts are going to 1% of citizens in Illinois.
 - Tiff District
 - Accelerated depreciation losing \$1 billion every 3 years.
 - Vendor discount keep 1.75% of their sales tax Wal-Mart kept 9 million in 1 year

- Single sales factor 96-217 million a year companies get to keep
- Personal income tax employees pay their taxes directly to their employer 347 million dollars a year
- Dave is going to type up his notes and will put that on the website. If the state made their regular payments, the pension would be sustainable forever.

Any additional info you can provide when submitting classes is only to the teacher benefit (i.e. additional endorsement, change in class load). St. Francis has a new master's degree with 18 hours of electives.
- Try and work on getting people signed up on NUEA203.org website.
- Concern at the high school that with common core for science (i.e. DES and Earth Science) some
 courses will go away, some teacher may not be certified to teach the courses left. What is/what will
 be done to help those teachers to get them certified in biology, chemistry, and physics? At
 Executive Board will bring this up at next IPC meeting. The 3 teachers at North high school have
 already been informed about this pending issue.
- The water bottles that have been provided if you want to be eco-friendly, bring your own bottle and there is a water cooler in the lunch room. What has happened in 2010, is that the state changed it from being a certified school nurse to being just and RN state said just clarified. The rule now states that any RN can do medical rule.
