- Negotiation 5.10 a little higher than last money, we have been accumulating money in anticipation for negotiation, we are under budget from where he expected them to be.
- Item 3.27 this money was for the printing of the election materials last month NUEA voting
- Net Worth statement we have been building up interest in checking account (about \$50 a month). Money market will go down tomorrow with monthly check to the state.

- Can you share proposals? We took all the feedback from Culvers, RA meetings information, we listened and am trying to address all needs
- Moving along
- We can't share specifics at this time.

- Do you think the board has a sense of urgency to finish before school gets out? Mutual idea is
 to have done before school gets out, the NEUA has not gone back to school without a contract
 and we won't do that.
- Clarify work days or student days if that situation occurs. We are bargaining in good faith. In
 May we should Have a TA meeting or another meeting but will know more when later
- Negotiations have been very positive, there were a lot of things we have presented
- Has been very collaborative

6. GPA Report- School Board elections

Dave Madsen

- Romberg, Wandtke, Fitzgerald, Crotty were elected
- We emailed out 3000 to IEA members paid for from IPACE fund
- Order of priority
 - i. Pensions HB3411, call to action was sent out, couldn't get the votes to pass this through IEA opposed never called to vote because Madigan didn't have the votes, he wasn't going to bring to floor until he knows it can pass, we have a lot of people calling and lobbying. The one still staying there would lose 30% of their retirement basically not getting cost of living increase, what they want to do is cap it, this would create a tier 3
 - ii. SB2404 died last week, even though had 24 people that sponsored it, usually takes 30 sponsors to force a vote on the floor,
 - iii. If you go to IEA website pension/legislative fact sheets
- If they eliminate our benefits what happens 10 years from now when our benefits aren't being taken any more – state overspends
- COLA is a flat rate of 3% put in, in 1972, the flat 3 over time
- Mark this year the state 670 billion dollar economy 5th largest, but at the bottom in funding education. We need to have our young professionals contacting the state about these issues.
- Concern that it is hard to get new teachers to buy in to the union when there doesn't seem to be
 a perceptions that union protects them.
- Virtual charter school moratorium HB494 has passed the house and in the senate, all 18 other districts have voted the K12 Charter down.
- Question about the commission it is a board appointed (3 members has connection to charter schools). The commission can overturn what the school board's vote down a charter.
- During the board presentation K12 spoke about differentiation but couldn't answer questions on how differentiation worked except for modules kids worked through.
- Our district sent in 150 questions company returned 1,080 page document that didn't answer questions and sent same document to all the other school districts
- The larger fight will be with the commission local large presidents working together
- Question about collaboration between 18 districts superintendents and school boards all working together.

- Question on student performance who does it reflect on K12 or the district? Reflects on the charter school – wouldn't be back on teacher unless the student is back in the district – but is based on what level the kid comes back into the district at.
- How many on the commissions 9 (1 member was part of the closing of Chicago schools and opening charter schools).
- If moratorium goes through have 1-2 years to get to the commission.
- In IL we have a moratorium on new charter school regulation that expires June
