- Charter School Open hearings
 - Mark had list of the meeting dates and encourages you to attend in your district "virtual learning solutions at fox valley" – claim to be non-profit.

- They come in to our schools, take some students, take the cost per student from the district, up to 125% of cost per student, student logins in, also says should have a parent/adult with them similar to home schooling, little accountability, students are opting out of the program but the money is already gone to the company and district doesn't get any money back.
- o We are opposed to this. We have Dave Madsen, Lisa Yost, Carol Higgins, Dan Iverson.
- o Mark is not speaking.
- O Dave Madsen = their CEO makes \$5 million a year, that is all tax money in to their pockets
 - At a community meeting sales man was asked how much he made wouldn't answer the question
 - 5 guys that started this, one is former president of Naperville chamber of commerce, is a front for K12 to get money.
 - 18 districts in proposal
- Next step k12 goes down the Charter commission if our school board says no
- Then district goes down to Springfield
- Dave Madsen commission was funded from private foundation
