- UNIServ Director's Report
 - bargaining with NESPA
 - was going well until financials began being discussed
 - FMLA/Maternity Updated
 - six weeks even with a summer baby (paid); eight weeks if C-section
 - men also have a 12 week unpaid FMLA leave (if you both work for the district, they may ask (compel) you to split the time
 - if there is a doctor's note saying that your spouse MUST stay home to care for the birth mother, you may take sick leave and FMLA
- GPA Report
 - sparsely attended
 - legislative update
 - HB397 is coming up to vote (charter school)
 - gives control back to the community (no state entity can overturn the decision of the local school board
 - call your Rep. to support the bill
 - this year's budget
 - cut \$115 million from K-12
 - some districts may not be able to pay their employees (loss of 3 teachers per district for a whole school year)
 - PARCC HR54 (non-binding resolution)
 - IEA supported resolution to encourage school districts to not use PARCC results to determine student opportunities nor for teacher evaluations

- Opposition to Pension Cost Shift
 - shifting the cost of TRS pension costs to the suburbs and local school districts
- NEA Director Report
 - Senate is taking up the ESEA bill in April
 - contact Mark Kirk and Dick Durbin
 - less testing giving students more time to learn
 - insuring qualified educators and encouraging them to lead
 - less emphasis on test scores
 - state legislators
 - instead of Lobby Day, contact your state legislators in the next two weeks (while they are home); Joyce is willing to go with you to help set up a meeting and talk with them with you; she can also give you some talking points for meetings
