- Performance of the program
- performing exceptionally well
- 20% of educators are emerging educators
- 81% do have masters and are within Career 203
- decisions are not made in isolation
- question asked about breakout of newer teachers vs experienced, grade level comparison, positions: response- can't because things are constantly changing, but has data on hand
- question do we have a comparison between prior to career 203 data, like number of participants in district courses: response - no real response given
- discussion about teaching professional learning course...the points vs pay conversation
 - i. clarification that people either get points or payment
