10. Student Behavior IPC Mark
- Hearing student behavior is slowly getting out of hand, specifically at the elementary level.
 - Christine Igo confirmed that it isn't handled consistently across the district
 - Difficult when students have IEPs
 - When student is issue in one class at high school, not much communication between classes
 - In the fall we should have procedure, protocol and policy come this fall
 - We requested that the form be quick and easy to complete
 - Try to get principals to get things over to Christine Igo instead of just them staying at the school.
 - Was there a specific timeline when these procedure, protocol, and policy were to be shared?
Mark - with 2 days before teacher work day is when it should done
 - Paula - was there any talk about staff being pulled to deal with crisis and documenting minutes missed from servicing other students? Also asked about discipline policy - Mark will share that out to Reps for sharing in the school.
 - Request for IPC to talk about personal property being destroyed by students also about what happens with the student in crisis stays in the room and rest of class has to leave - what about if school has no space to take class
