School Board Elections

Mark

- On Jan 9<sup>th</sup>, Debbie Sternecky went to the DuPage Democrats meeting. Over 500 people one and former Governor Quinn was there.
  - o They want to replace Rauner
  - They want 6 people on DuPage committee
  - They want to get out the vote.
  - Website: indivisibleguide.com: They are forming a committee. They have a guide to download. Tomorrow: call or write senators. Ask them to vote on cabinet picks.
  - On January 8<sup>th</sup>, Jim Reed (IEA government relations, Republicans and Democrats are negotiating to reduce pensions for active teachers, limits for pay raises that are pensionable)
  - Bills to watch for
    - SB75 Buses for seat belts
    - Tier 3 savings plan that is not a pension that would be funded with employer and employee and let people get out of paying into the pension system.
    - 2022 to 2027 the Tier 2 pensions, the pensions will not meet safe harbor and then the state and you will have to pay for the pension contributions on top of their current pensions.

Question: is there anything in the law about retirement bills?

Answer: no

Dan: is there a requirement to get rid of PE because it is tied to the pension bill?

Debbie stated that IEA will let us know and that we should contact our state legislators.

Dave Carroll wanted to add that we have the lowest income tax in the US. However, we have the highest property taxes and there is a huge disparity. Problem with freezing the property taxes and there are several districts who will not be able to have flexibility and not operate.

Property tax freeze: district 203: It will affect us that it will hit us by 19 million dollars.

- HB433: establish a voucher system. Once a student is expelled from a private school or a charter school back to the public school, the public schools do not get the money back.
- You can download an IEA app and they will send us alerts to things. They don't bother you much.

- There is one unexpired one 2 year term. There are 4 year terms.

- Anything that we can find out would be helpful. Recommendation hearings will be held. We will ask the same questions of each board member. On the committee will be the presidents of the locals: NUEA, NESPA, NTA and NUMA. We do internal recommendations and do not put it out in public. However, the candidates can decide whether they wanted to say they were recommended. Candidates' statements are already out to run and whatever they put out is up to them. NUPACE dues (from a fund that is from the state) will help the candidates that we recommend for signs and telephone banking, mailers, palm cards for our members.

(which can be working conditions) The only thing that will happen next year is that late start at the high school level will be once a week to allow for PLC's at the high school level. At the elementary level, there is grade level time. That doesn't exist at the high school level. There is a possibility in the next year that perhaps the high school day will start later. Dan Bridges doesn't want to do it if it is a cost to the district which would be in transportation. (getting the buses through Naperville in the morning) The discussion around the elementary school day is that an extra ½ an hour would be beneficial, but they want to take a step back and do a deep dive and see the structure of the school day right now and see if there would be a way to restructure the day we have right now. At the IPC, we did talk about

the late start at each level, but so far, there are not interested at this point. Dan Bridges felt that it would be a day care issue.

- Paula Helberg: the LRC directors are right now at the elementary level take the grades for those grade levels PLC, but those positions will be changed so that time might go away.
- Mark: understand that any changes in the working day must be negotiated. They can say to the high school, we will start at 8:30 instead of 8:00 as long as they don't add time.

Question: Update on maternity leave: Mark stated that the lawsuit has been filed but we don't know when the case will be heard. Could be up to a year. There are 6 cases all centering on the same issue.

The district is still looking at family leave is a disability. The law states you have 30 days for family leave/birth of a child unpaid. If you have sick days available, you may use your sick days for recovering and the beginning. If you have a child before winter break, school is saying that the 10 day period over winter break, they take the 10 days off and you only get 20 days. Our position is that it should start the first available day when you come back to work.

Question: The district thinks it is too sickly?

Mark: The district feels that if you have the child over the summer, you get extra time. Question: At the high school level, why is the district willing to pay for curriculum pay during the day, but not for PLC's after school? It is a way to get something for nothing. People should say no, but they won't.

Mark: We have to stop doing that as an association and take the sub during the day. Bring this up at IPC to talk about this.
