- v. Consider the minimum teacher salary from \$9,000 to \$40,000- JB wants this to be the first bill he signs into law.
- vi. Senate Bill 28 Evidence based funding bill specification regarding school day. on a snow day, if school can send work electronically, would this day count? IEA is pushing for language that states teacher/student interaction and must continue the school day.
 IEA doesn't want technology to replace the teacher. IEA doesn't want the flexibility to be used against us have a caseload of 100 online students.
- vii. Mindy can't endorse any of the candidates during the election in her position.
- Mark 3% was put in the budget at the very end of the deadline. 6% was the cap. Our concern, 80% of our workers are female, 70% take some time off to raise children therefore, they don't make max when they retire. District 204 did research on how to recapture the money lost to make up. They are cost shifting the cost of pension to the districts.
- Mindy needs help with our GO Team we need at least 5 of us to work with her.
- 7. School Board Elections
 - April 9 is school board elections. There are 6 candidates: Char Lynnette Dalton,, Becky Rudolph , Cecilia Fox, and Joseph Kozminski, Kristine Gericke, and Janet Yang Rohr

You as a leader, may endorse a candidate as a dues paying member, not as a building rep or exec board member. GPA and Uniserv Director can't endorse a candidate. Mark will not endorse a candidate. He will answer specific questions.
- 9. MTSS What's Happening? Anything new? All levels
 - NCHS we think something is coming. Bill is meeting with us during 6th period. Mark said no survey of our staff this is a negotiated topic. You don't get to ask this of membership.
